

## ESTABLISHMENT HIGH PRIZE GAMES AGREEMENT

This Agreement is made and entered into by and between \_\_\_\_\_

Whereas, SBG has provided Establishment with SBG skill games placed at \_\_\_\_\_

Establishment) and Establishment has a signed an Establishment Agreement; and

Whereas, Establishment wants to have High Prize Games (games that have maximum prizes above the standard prize level of \$2,000.00) at their location.

During the term of this Agreement all of SBG's Equipment shall not be removed from the location above without SBG's written consent.

Establishment acknowledges and understands that:

1. These games will require higher floats to be maintained by Establishment in order to payout prizes at applicable level selected by Establishment below.
2. Establishment must maintain a float (approx. \$1,000 - \$7,000 based on two machines) at all times to payout Cash Prizes – float requirements will depend on how much business is transacted.
3. Establishment is to balance sales (cash paid-out) and pay-outs (gift certificates and cash prizes) and empty Bill Acceptors in Units **on a daily basis** and any discrepancies are to be reported to SBG within 48 hours.
4. Establishment is responsible for paying out all prizes, including cash prizes.
5. As per the previously entered Establishment Agreement, Establishment has authorized SBG – Skill Based Games Inc. (SBG), and Bank of Montreal, the financial institution to begin deductions as per these instructions for weekly variable payments, for payment of arising under the Establishment Agreement. If there are chargebacks, SBG at its sole discretion has the right to remove any and all High Prize Games.

6. These High Prize Games will be available to the patrons of the Establishment until the Establishment notifies SBG they no longer want them or SBG cabinets/bar-tops are removed.
